**Chief Justice James W. Hardesty**



Chief Justice James Hardesty serves as the Chairman on the Commission to Study the Administration of Guardianships created during the 78<sup>th</sup> Nevada Legislative Session. Born and raised in Reno, Chief Justice Hardesty has practiced law in Nevada since 1975. He was elected to the Nevada Supreme Court in 2009. In September of 2015, Justice Hardesty was elected Second Vice President in the National Conference of Chief Justices.

Senator Harris is a member of the Commission to Study the Administration of Guardianship. During the 2015 legislative session, Sen. Harris sponsored Senate Bill 262 which provides for the appointment of a guardian regardless of Nevada residency status. Sen. Harris is a member of the Nevada State Bar and the Nevada Dispute Resolution Coalition.
